Bullying, Harassment, or Intimidation Reporting Form

Definition: A person is bullied when he or she is exposed, repeatedly and over time, to negative actions on the part of one or more other persons. Bullying, harassment, and intimidation are serious and will not be tolerated. This is a form to report alleged bullying, harassment, or intimidation that occurred during the current school year on school property, at a school-sponsored activity or event off school property, on a school bus, on the way to and/or from school, or on the internet-sent on or off school property; or that substantially disrupted the orderly operation of the school.
